2 Recap of Historic Environment Action Plan process and HEAP promotion since February 2011

The Historic Environment Action Plan documents were created between February 2009 and February 2011. This process was funded by EH as a best practice exemplar for other areas.

The project was formally launched in February 2011, additional promotional events have been undertaken aimed at planners and South West protected landscapes. In addition the project officer gave a presentation on HEAPs to the Irish Heritage Council.

3 Discussion and Agreement of Implementation Group Terms of Reference

Discussion of Implementation Group Chair

The purpose and aims of the group as set out in the Terms of Reference was accepted.

It was suggested that the outputs from the Action Plan needed to be clarified, and that the scope of end products should be carefully monitored and kept manageable.

The initial plan period was agreed as 3 years

The structure for future meetings was agreed.

The Implementation Group will initially split into 2 subgroups focusing on different types of actions. These groups will meet for the first time in the next 6 weeks and determine format and regularity of meetings.

Sub Group One (Chaired by Laura Bullivant & Claire Ryley) will focus on: -

Actions that deal with a Lack of Information or Knowledge AND a Lack of Appreciation or Understanding

- Broad Coverage
 - Initiates, undertakes and co-ordinates implementation of actions which deal with a lack of information or knowledge
 - Initiates, undertakes and co-ordinates implementation of actions which deal with a lack of appreciation and understanding
 - Promote public understanding and enjoyment of the historic environment of the AONB
 - Helping to promote a multi organisation approach to increase knowledge of the historic environment
 - Opportunity to share relevant and current initiatives across boundaries
- Potential Attendees AONB, County Archaeological Services, Museum staff, Academics, local experts and researchers, local heritage societies, English Heritage, AONB, local archives, volunteers, access officers etc

Sub Group Two (Chair to be decided) will focus on: -

Actions that deal with Heritage Under Threat AND a Lack of Appropriate Management

 - Initiates, undertakes and co-ordinates implementation of actions which deal with a lack of appropriate management
 - Opportunity to share relevant and current initiatives across boundaries and promote positive examples of good management
 - Helping to promote a multi agency approach to the management of the historic environment

- The Cranborne Chase Woodfair presents an opportunity to present information on the management of heritage in woodlands, and uncovering woodland archaeology
- The AONB will hear about its bid to the HLF for a Landscape Partnership Bid in 2011

Update from Jerome Laker – Interest from Knowlton in helping with historic routeways action

Update from Claire Ryley – Gold Hill Museum reopening next week. Working with Julian Richards and CBA on HLF bid 'What's under your School?' This will feed information back into the HERs, and will be a model of best practice.

Update from Wiltshire Council from Alison Rasey, Rights of Way and Countryside Team – Wiltshire HER is being upgraded to a new improved GIS system, a funding application to complete a Wiltshire HLC has been submitted to English Heritage.

Peter Addison, Historic Environment Field Advisor, English Heritage – ongoing work through the Dorset County Monument Management Scheme e.g. Cranborne Castle, and through new HLS agreements e.g. Wimborne St Giles Estate can be used to highlight new good positive management. Would welcome the opportunity to review overall impact of HLS schemes.

Update from Laura Bullivant, South Wiltshire and Salisbury Museum – HLF bid will provide revamp of galleries re-linking objects to the landscape, with a new Archaeology of Wessex gallery. Pitt Rivers Galleries and archaeological collections already form an important resource. Several forthcoming exhibitions are relevant – exploring archaeology of Cranborne Chase (autumn 2011), Vivien Leigh (2012) coordination exhibition of artists take on landscapes.

Wiltshire museums are exploring a joint project on Wiltshire and WW1 ready for 2014.

Ben Kerwood, CPRE – important to build on existing groups including Dinton Historical Society

John Gale, Bournemouth University – offered to look at the key aspect of best practice in engagement between communities and academics, and disseminating information out to communities.
